From the North:

Take Division until it merges with Brown Street
 Turn Left at Main Avenue
 Turn Left onto Division again
 Turn Right on Olive Avenue
 Turn Left at North Riverpoint Boulevard

From the South:

Take US-195
 Merge onto I-90 via ramp to Spokane
 Take exit 281 to merge onto Division
 Turn Right at Olive Avenue
 Turn Left at North Riverpoint Boulevard

From the Spokane International Airport:

Head Northeast on W. Airport Dr.
 Take the ramp onto US-2 E
 Take the exit onto I-90 E/US-2E toward Spokane
 Take exit 281 to merge onto Division
 Turn Right at Olive Avenue
 Turn Left at North Riverpoint Boulevard

From Spokane Valley:

Take I-90 West
 Take exit 282A to Hamilton St./Trent Ave.
 Turn left at East Spokane Falls Boulevard
 Turn right at North Riverpoint Boulevard
